## **Diversity and Advocacy**

### Trans and Gender Expansive Youth are Loved, Supported, and Valued

On February 8, 2024, Nex Benedict, a vibrant, successful, Choctaw, non-binary teen died. The story of their death is the subject of many national media stories, TikTok reels, Instagram posts, and conversations among families throughout the country. Because of the internet, social media, and how fast information can get disseminated, it is difficult to know what exactly happened and what is happening now in regards to the investigation. What is known is that Nex Benedict died, a family and tribe are grieving, and the trans/gender expansive community is heart broken.

I wanted to write about this when I heard about it and found myself having a hard time sitting down and doing it; mainly because of all the feelings I noticed in my body including anger, sadness, grief, passion, and empathy. As a parent, I feel a deep grief for Nex's family. I definitely hugged my little one tighter the last few days. As a genderqueer person, I feel infuriated at the lack of action by the school, and the continued, hateful rhetoric we hear from elected officials. As an activist, I feel the need to do something, to make noise about the injustice. As a human, I feel sadness about how we treat each other and gratitude for the community rising up to support this family in Oklahoma.

I am an activist for the trans/gender expansive community, and so I want to do something in response to this tragedy and feel like I come up short. There are candle vigils being coordinated in Oklahoma and across the country. There is a GoFundMe to help Nex's family with expenses. Many famous people, including Vice President Kamala Harris, are posting messages on social media. What else can we do? Where can we make a difference in the hate that is constantly spewed to our community? I believe it is not through responding with hate, going after people through verbal, hateful speech. I believe we do have to hold people

accountable for their actions and words, through empathy and conversation, not hateful posts on social media. The adults in Oklahoma, at the local and state level, need to be held responsible. We need to demand justice for Nex Benedict and their family. We need to look farther down the road and strategize about how to battle this hateful, dark Nothing (yes, Nothing, from The Neverending Story) that is plaguing our country. Educate ourselves on who is running for office this year, what have they voted on in regards to bills or laws targeting the trans/gender expansive community. It is time we get away from voting for a party and vote for people who know the importance of keeping members of our communities and country safe.

We need to make it known to our trans/gender expansive youth that they are loved, supported, and valued. According to GLAAD,

The impact from Nex's death is being felt throughout the Owasso community and beyond. Rainbow Youth Project, a social welfare nonprofit organization that promotes the health, safety, and wellbeing of 2SLGBTQ+ (Two Spirit, Lesbian, Gay, Bisexual, Transgender, Queer) young people throughout the United States, reported 349 crisis contacts received between February 16th and February 20th. Incoming contacts usually average 87 per week.

Gender expansive teens deserve to live to be gender expansive adults. They deserve to go to school and be safe. They deserve to live authentically, happily, and joyfully. Find a gender expansive youth, gender expansive adult, gender expansive member of your community and let them know they are loved. Support them when you go to vote. Support them at school board meetings, at the county

commissioners meeting, at the church leadership meeting. Ask leaders in these meetings how they support the trans/gender expansive community. Compassionately challenge people in your life when you hear hateful comments or microaggressions about the gender expansive community.

Lastly, we need to examine our own thoughts and feelings about the trans/gender expansive community. Evangelical community members (I feel it is an insult to call them Christians because they do not exemplify the teachings of Christ) and far-right political party members spew hateful speech that influences people and policies that lead to tragedies like the death of Nex Benedict.

This is a tragedy, and we need to come together as a human community to fight against this violence. Within our righteous anger, we need to be aware of respecting the Benedict family, other advocacy organizations, and not using Nex's death as the next viral hashtag that is forgotten in a week. This family and community are going to need support for longer than a week. At this time, the community needs to respect the Benedict family, give them privacy to grieve, and adjust to this new life for their family. We do not need to steal activist language from Black Lives Matter, so please refrain from using "Say Their Name" when posting about Nex Benedict. Find within yourself what your capacity is for tackling the hate you hear. Do what you can, it takes all of us!

# MGCA-NC: First Responders, CEs & Students... Oh My!

Did you know that North Carolina has one of the largest military communities in the United States? We have the fourth largest active-duty population thanks to large bases like Fort Liberty, Camp Lejeune, and Pope Air Force Base. We have the eighth largest population of veterans as many opt to stay in North Carolina after their service. These veterans are dying by suicide at a 55% higher rate than non-veterans. At MGCA, we are committed to supporting the military and government employees by helping prepare more counselors to support them. This month, we have several exciting updates.

First, at MGCA, we have historically had greater focus on the military as many of our members have ties to that community. Although we aspire to have all of our programs apply to any client who walks through your door, we have tended to use examples from the military to illustrate points. We are pleased to be expanding our focus to include first responders as we have new members with experience in those spaces. Although many of the challenges are similar, we hope to address some of the unique issues that first responders face.

Bill Stewart is a Licensed Clinical Mental Health Counselor — Associate who works in private practice where he spends part of his time working with the military community. Bill is the current president of the Military and Government Counseling Association of North Carolina and is the Member-at-Large for Government Affairs for NCCA. Prior to becoming a counselor, Bill served as a paratrooper in the 82nd Airborne followed by a career at Johnson & Johnson. Bill also holds an MBA from Duke University.
