The Counselor Preparation Comprehensive Exam (CPCE) was scheduled exactly a week away from the day of writing this reflection, and the National Counselor Exam (NCE) 10 days after the CPCE. A few months back, when COVID-19 cases were declining and public spaces began to open back up, I was wishfully expecting graduation in the fall would be in person. I wanted the chance to walk across the stage with my peers who have made this marvelous journey through master's-level academics and a dedicated supervised internship experience (often, we did all this with full-time jobs, young children, and other family responsibilities). In fact, all my clients during internship never set foot in front of me in an office or waited for their call in something other than a virtual waiting room.

Of course, many students and professionals have been using virtual resources for decades, a reality that Telehealth training has revealed about a bustling medium for delivering mental health or educational services. No doubt telehealth will persevere after the wake of the pandemic, and this is quite a good thing for many people who would otherwise go underserved. As someone interested in rural mental health, access into remote corners and pockets of our state to provide these services will prove its value in years ahead, if it hasn't already.

I write this reflection as a call to celebrate those achievements which have come to us during the pandemic. Of course, our usual patterns of celebration maybe closed or nearly impossible, but even more reason for a clever new pattern to accomplish the same means. During the pandemic, one of my new patterns has been hiking, and state parks have seen a rise in visitors over the course of the pandemic; another impact I hope remains long after the COVID dust has settled. The pandemic has cast a shadow over these achievements for us new graduates and beginning practitioners. Although our graduation will be virtual, nature will continue to give us challenges to surmount, but if a major virtual success like graduation and licensure has anything to teach us, it is that we are capable. You are capable. So, to all the new graduates who have completed their programs while maintaining other employment, caring for family needs, responding strongly in the face of threat, cheers to you, and best of luck moving forward into the counseling field.

Dr. Samuel T. Gladding was a Professor at Wake Forest University in the Department of Counseling.
