1. Provided Cover Page.
2. The Narrative (up to 1000 words) relates to the conference's theme: ***Change, Adapt, or Lose: The Imperative for Advocacy in Counseling.***
3. Curriculum Vitae (2 pages max)
4. Two (2) Letters of Support

Letters should include the reasons why the nominee is deserving of this recognition.
